Technical Evaluation: Technical evaluation shall be carried out on pass/fail basis according to following criteria's. If a bidder fails to comply with single criteria mentioned shall be rejected

- 1. Complete contact detail of bidder is provided on the envelope.
- 2. Bids are submitted in seal envelope
- 3. Bids are submitted within due date
- 4. RFQ is signed and stamped by the bidder and enclosed with technical bid documents
- 5. Bid security is submitted with technical bid documents

Financial evaluation: Quotations that are found to be technically acceptable shall be evaluated based on price and AKRSP will award the contract to best responsive bidder

Terms, Conditions and Quality Standards

- 1. Interested reputed and well authentic suppliers having established local nurseries must provide their quotations, printed or hand-written on firm's letterhead in seal envelope. Further, interested suppliers are requested to provide their quotations for all items as average rate for each items, in accordance with the format prescribed in the aforementioned RFQ.
- 2. Safe transportation of plants to respective valleys/delivery points will be the responsibility of respective supplier. Provided rate must be inclusive of transportation to mentioned valley/area.
- 3. During the supply of afordmentioned plants to the valley, the supplier will make his own arrangements for travel, stay and food etc. Moreover, he will provide all the means needed for the said purpose at his own cost.
- 4. The purchaser will arrange its own independent inspection team at the time of delivery to ensure successful delivery by supplier.
- 5. Identification of sites in each valley/selected locations shall be responsibility of purchaser
- 6. Successful bidder shall be asked to provide sample of each above mentioned plants to ensure quality standard.
- 7. Physical verification of required stock having at least 50,000 Nos plants availability at nurseries shall be checked and ensured by AKRSP team.
- 8. For transparancy and quality assurance AKRSP representative will be available in supplier premisis at the time of uprooting the plant.
- 9. Till starting of plantation season in valleys/selected areas,safe storage of all plant shall be responsibility of the supplier. During storage if any plants become dry up, the will be responsible to replace death plants on his own cost and AKRSP will not be responsible to bear any cost in this regard.
- 11. AKRSP maintains a record of existing and past rates of various goods, supplies and services. If at any stage of procurement, AKRSP finds the apparent and clear difference between rates provided in the quotations and prevailing market rates as per said records, AKRSP holds the authority to cancel the whole procurement process and all suppliers, involved in such cartelization shall be blacklisted. Further, same entity/ individual shall not be allowed to float the quotations with different name.
- 12. The supplier is bound to supply the forest plants as per plantation season on specfic duration and points provided by the purchaser.
- 13. Bidders are requested to sign and stamp the RFQ and submit with technical bids, without which bids shall not be considered for evaluation.
